TERMS OF SERVICE & MEMBERSHIP AGREEMENT

1. INTRODUCTION AND ACCEPTANCE OF TERMS

These Terms of Service ("Terms") govern participation in The Beaudega Bottle Club ("Bottle Club," "Membership," "Program"), operated by The Beaudega, Beaufort, North Carolina ("The Beaudega," "we," "us," or "our"). By enrolling in, accessing, or participating in the Bottle Club in any capacity, you ("Member," "you," or "your") acknowledge that you have read, understood, and agree to be legally bound by these Terms. If you do not agree to these Terms, you must not enroll in or participate in the Bottle Club.

2. ELIGIBILITY

Membership is available only to individuals who are at least 21 years of age, can lawfully purchase and consume alcohol under applicable laws, and provide accurate registration information. We reserve the right to deny or terminate membership at our sole discretion.

3. MEMBERSHIP TIERS

The Beaudega Bottle Club currently offers multiple membership tiers, all subject to change at any time. Tier 1 is a complimentary membership providing newsletter access. Tier 2 is a paid membership providing preorder access, event invitations, complimentary corkage, members-only content, and tasting notes. Tier 3 includes all Tier 1 and Tier 2 benefits plus the option to select up to two featured wines per month when available.

4. WINE SELECTION AND PURCHASE TERMS

Featured wines are curated monthly and availability may vary. Selection windows are time-limited. Failure to select within the window results in that month being skipped without refund. Wine purchases are optional and separate from membership fees.

5. PICKUP ONLY – NO SHIPPING

The Beaudega does not offer shipping of wine. All wine purchases must be picked up in person. No refunds or credits will be issued for unclaimed wine.

6. FEES, BILLING, AND PAYMENTS

Membership fees are billed regardless of wine purchase activity. Fees are non-refundable except where required by law. Pricing and billing structures may change at any time.

7. CORKAGE AND VENUE PERKS

Complimentary corkage applies only to wines purchased through The Beaudega and is subject to venue policies. Corkage perks have no cash value and may be modified or discontinued.

8. EVENTS AND TASTINGS

Events may have limited capacity and require registration. Attendance is not guaranteed. Participation is voluntary and at the Member's own risk.

9. ASSUMPTION OF RISK

Alcohol consumption involves inherent risks. Members voluntarily assume all risks and agree to consume responsibly.

10. LIMITATION OF LIABILITY

To the fullest extent permitted by law, The Beaudega shall not be liable for indirect or consequential damages. Liability shall not exceed membership fees paid in the preceding twelve months.

11. MODIFICATION OF MEMBERSHIP AND TERMS

The Beaudega reserves the absolute right to modify membership tiers, benefits, pricing, and these Terms at any time.

12. TERMINATION

Membership may be terminated without refund for violations, misconduct, or legal requirements.

13. NO WARRANTIES

The Bottle Club is provided as is and as available, without warranties of any kind.

14. INDEMNIFICATION

Members agree to indemnify and hold harmless The Beaudega from claims arising from participation or violation of these Terms.

15. GOVERNING LAW AND VENUE

These Terms are governed by the laws of the State of North Carolina. Venue shall be exclusively within North Carolina.

16. SEVERABILITY

If any provision is unenforceable, remaining provisions remain in effect.

17. ENTIRE AGREEMENT

These Terms constitute the entire agreement between the Member and The Beaudega.
